

~*~ Guardian Council Charter ~*~

1. GENERAL

1.1 The Guardian Council is located in Albion, on the Igraine server within the Dark Age of Camelot MMORPG. The guild was founded in September 2002 for the purpose of having fun, exploring, meeting new people, providing access to groups, equipment, and knowledge to its Members.

1.2 The Guardian Council shall consist of the Council Leaders and 5 High Council Members, and unlimited standard members.

• Rank 7	Knight Lieutenant	lvl 20 – 29
• Rank 8	Knight	lvl 10 – 19
• Rank 9	Squire (Probationary Rank)	lvl 1 – 9

1.3 It is a requirement that Members accept the terms of this Charter.

2. MEMBERSHIP & DUES

2.1 The following basic conditions attached to Guild Membership:

- Thou shall honor, respect, and support my fellow councilmen and assist them first and foremost beyond all others within the realm.
- Thou shall not murder, offend, slay, or otherwise betray my fellow councilmen and thou shall not argue with them in public.
- Thou shall serve my guild righteously and dignified, while pursuant to protecting and defending the innocent and those whom cannot fend for themselves.
- Thou shall show pride and confidence in my guild symbol, my fellow councilmen, and myself at all times.

2.2 Membership commences immediately upon a Guild Invite from a qualified Guild Member.

2.3 Membership Dues are due the 1st week of each month to any High Council Member or the Council Leader(s)

2.4 Guild Meetings are held once a month on the first Saturday of each month. These meetings are **MANDATORY** for **ALL COUNCIL MEMBERS**.

- Members are required to attend all guild meetings unless a good reason is provided to a <High Council> Member at least 48 hours prior to meeting date, barring emergencies. (See above for <High Council> Ranks)
- High Council Members who have 3 unexcused Guild Meeting absences will be demoted to general membership based on level, forfeiting their council seat. A three Month period of participation will be required before reconsideration for Councilship based on vacancies.
- General Members will be exempt from any guild loan considerations at any meeting they are not present for.

2.5 Membership Dues are necessary to assist our Guild Members with equipment, armor, skill training, and guild emblems. Dues are determined by rank and viewable each month in a downloadable PDF file via the Guild Website accessible to ALL Guild Members. Dues are mandatory. Minimum dues are 1 gold per month

2.6 Loans from the Guild Fund must be applied for via the guild message board in the ***GUILD FUND REQUEST*** section. The High Council will vote fund approvals at the following Guild Meeting. The following requirements apply for Guild Fund approval:

- All loans must be paid back within 3 months after receiving loan.
- You may only have one loan out at a time.
- Amounts will vary based on number of applicants, reason, and amount in guild fund.
- You must be a member of the guild for 2 months before applying for a loan.
- Must have good standing within the guild based on, but not limited to; guild meeting attendance record, participation in raids, group support, etc.

3. THE HIGH COUNCIL

3.1 The High Council is made up of the Council Leaders and 5 High Ranking Officers.

3.2 The purpose of the High Council is to assist, support, organize, and defend the guild and its purpose at all times.

3.1 High Council Officers shall be experienced players with approximately 20 levels gained.
